# **AMFA Educational Trust Grant Parameters**

The AMFA-ET is a 501(C)3 nonprofit organization that disseminates information about employment opportunities in manufacturing, provides grants to regional educational institutions, supports lifelong learning in technical education.

Organizations eligible for grant funding are 501(C)3 nonprofits, schools, and other public entities located in or serving the communities represented by the AMFA membership. To be considered, requests must address at least one of the following three priority areas.

- Employment opportunities in manufacturing
- Grants to educational institutions
- Lifelong learning in manufacturing-related education

## The AMFA Educational Trust WILL consider grant requests for:

- Existing programs, expansion of program, and projects that are time-limited in nature.
- New programs/organizations that demonstrate clear and relevant goals.
- Programs and educational activities that seek to build capacity.
- Repeat applications, although priority will be given to NEW requests.
- Robotics programs/competitions. (Maximum award of \$500/team. Please note deadlines.)

## The AMFA Educational Trust generally WILL NOT consider grant requests for:

- Programs/projects outside the priority areas or taking place outside the membership area.
- Grants to individuals, businesses, or private foundations.
- Sectarian religious programs.
- Endowment, capital campaigns, or support for fundraising events.
- Replacement of traditional government services or employee wages/salaries.
- Funding on continuous/duplicate basis.

### The AMFA Educational Trust is interested in funding initiatives that:

- Expose youth to career opportunities in manufacturing
- Expose parents/teachers/influencers to career opportunities in manufacturing
- Impact/create a favorable perception of the manufacturing industry
- Increase the supply of skilled labor for manufacturers in the region
- Feed the pipeline for manufacturing-related technical education, including high school technical education equipment, curriculum, supplies/materials, field trips and competitions.

#### **SELECTION PROCESS**

Eligible proposals will be reviewed by the AMFA-ET Board of Directors on a biannual basis. The applicant may be asked to field questions in a personal meeting or conference call.
